



THE VICTORIA PROGRESSIVE ROYAL FLUSH JACKPOT TERMS AND CONDITIONS

1. This promotion is valid only at Grosvenor Casinos The Victoria, London.
2. The Progressive Royal Flush Jackpot will run from 6am Monday 20th July 2026 to 6am Monday 21st September 2026.
3. The Royal Flush Jackpot promotion has two jackpots available to be claimed.
4. In the Flop jackpot a player must flop a Royal Flush in any suit using both hole cards.
5. In the Turn or River jackpot a player must either turn or river a Royal Flush in any suit using both hole cards.
6. A claim to either of the two jackpots will payout 50% of the shown jackpot amount.
7. Both jackpots will increase by £1,000 per day during the promotional period.
8. In addition to the standard rake, a further £1 will be taken from every pot of £10, or more, on all raked No Limit Hold'em (NLH) cash games.
9. A "qualifying period" shall be determined as between 6am and 6am.
10. If a player does not make the dealer aware that a claim is being made, prior to the hands being mucked, there can be no claim on the promotion. The Supervisor/Manager must be called to verify all wins.
11. When running a hand twice, only the first board will count towards the promotion.
12. Hands do not have to go to showdown to qualify, pot must be £10 or more to qualify.
13. Allocation of prizes will be made as soon as possible, though shall be completed within a 24-hour period.
14. A 10% admin fee will be taken from the collected £1 promotional charges.
15. Any additional promotional funds collected will be held in reserve, and awarded periodically, including but not limited to, additional prizes and places paid.
