



THE VICTORIA SUIT OF THE MONTH TERMS AND CONDITIONS

1. This promotion is valid only at Grosvenor Casinos The Victoria, London.
2. The Suit of the month will run from 6am Sunday 1st February 2026 to 6am Friday 1st January 2027.
3. The Suit of the Month will be as follows:
 - a. Hearts for January, May and September 2026
 - b. Clubs for February, June and October 2026
 - c. Diamonds for March, July and November 2026
 - d. Spades for April, August and December 2026
4. If a player 'Flops' any straight flush in the suit of the month, they will receive a payment of £500, to be placed on the players deposit account.
5. If a player 'Turns' or 'Rivers' any straight flush in the suit of the month, they will receive an instant payment of £250, to be placed on the players deposit account.
6. If a Player 'Flops', 'Turns' or 'Rivers' a Royal Flush in the suit of the month, the prizes above (Point 4 and 5) will be doubled (£1,000 and £500).
7. In addition to the standard rake, a further £1 will be taken from every pot of £10, or more, on all raked No Limit Hold'em (NLH) cash games.
8. A "qualifying period" shall be determined as between 6am and 6am.
9. If a player does not make the dealer aware that a claim is being made, prior to the hands being mucked, there can be no claim on the promotion. The Supervisor/Manager must be called to verify all wins.
10. When running a hand twice, only the first board will count towards the promotion.
11. Hands do not have to go to showdown to qualify, pot must be £10 or more to qualify.
12. A player must create their best five card poker hand, using both hole cards dealt.
13. Allocation of prizes will be made as soon as possible, though shall be completed within a 24-hour period.
14. A 10% admin fee will be taken from the collected £1 promotional charges.
15. Any additional promotional funds collected will be held in reserve, and awarded periodically, including but not limited to, additional prizes and places paid.
