- **The Estate** The Deceased's Estate consists of everything they own such as Cash / Bank / Building Society Accounts, Property, Insurance Policies, Jewellery, Stocks and Shares.
- **Commissioner for Oaths** A person who is appointed by the Lord Chancellor with power to administer oaths or take affidavits, such as Notaries Public, Solicitors, Barristers, Legal Executives and Licensed Conveyancers.
