A consultant has been appointed to support the process and coordinate the data required for the submission. • The annual assurance statement has been submitted by the Council’s S151 officer. • Item 1.7 Proposals • Cost pressures remain across the Towns Fund programme as projects progress through the RIBA stages and the delivery stage is de-risked. • The ADMC project has seen an increase in costs associated with the S278 (highways) works and inflation which was managed through value engineering and reallocation of funding. • The Council is seeking through full Council, approval to bring forward a contribution towards these S278 development costs which will benefit the wider site. This would free up £1.75 million from the ADMC budget to manage cost risk across the Towns Fund programme. • Kingsway Park Sports Hub - Undertake value engineering to reduce cost by 150k. Secure 600k balance from ADMC reallocation detailed above.

	<ul style="list-style-type: none"> North Kirkby Gateway - Develop overall project to stage 4 detailed design and secure planning. Explore capital funding options for phase 2 block through Kirkby Long-term Plan for Towns programme/ capital receipts and borrowing.
	<ul style="list-style-type: none"> The board were asked to approve the cost mitigation options set out and to allocate funds where identified.
	<ul style="list-style-type: none"> Cllr Relf proposed, and Tim Hepke seconded.
	<ul style="list-style-type: none"> 2.0 UK Shared Prosperity Fund (UKSPF) The funding allocation for Ashfield for 2025-26 has been confirmed by EMCCA as £1,305,17 (Capital - £571,831, Revenue - £733,346). 39 bids were received from partners with requests for funding of over £2.88m. The Funding Subgroup met on 26th February to discuss the process for allocating funds and consultants have been appointed to undertake a scoring process based on criteria including alignment to UKSPF interventions, response to identified local challenges, links to Ashfield strategies and action plans, local opportunities, additionality, transformative potential, deliverability and risk assessment / experience of delivery. The funding subgroup will reconvene to review the scoring and to agree recommendations to the board. There is currently a review taking place of the 2022-2025 UKSPF underspend. This will be on the next Board meeting agenda.
	<ul style="list-style-type: none"> Joelle added that EMCCA had held back funding for regional projects. This largely covers business support such as start-up support. There are also three other aspects in their pilot stage. These topic areas are exports, workshops and training and scale up business support. They have also approved further funding to support the visitor economy and inward investment activity in the region. There is work ongoing to commission Marketing Nottingham to provide this work.
	<ul style="list-style-type: none"> 3.0 Kirkby Long-term Plan for Towns The national programme has now been renamed Plan for Neighbourhoods. The guidance has recently been released, and Sarah is in the process of writing a briefing paper on this. It looks to be relatively unchanged in many areas, with the governance still the same. The list of interventions is broader giving more scope. The Kirkby Town Board will meet to discuss these changes. The subgroups have continued to meet.
	<ul style="list-style-type: none"> 4.0 Hucknall Levelling Up Fund Government has confirmed the withdrawal of the Levelling Up Fund grant of £9.2m from Hucknall. Council officers are working with partners to review opportunities to take the projects forward through other funding sources.
	<ul style="list-style-type: none"> Dave Williams thanked the Board for their support on their social values project to help locally unemployed people.

It is encouraging to see so many positive reviews from visitors from many areas of the country. I noted that a number of the “Days out” sites across the country on social media have lots of interest regarding the Observatory.
	<ul style="list-style-type: none"> The visitor centres across Ashfield are attracting a large volume of visitors. The trails network and quality of the offerings are to be commended. Where once, they were just there to provide facilities for tea and coffee, toilet stops etc, they now offer so much more including Teversal Visitor Centre, Brierley Forest Park and Mill Waters, and others.

Having spoken to Hollie and Sarah, there is scope for updating the offering to include school visits, walking and community group visits, and much more. A number of these groups have already expressed a great interest in visiting.

Regeneration Programmes update, March 2025

This report focuses on the UK Shared Prosperity Fund programmes for 2022-25 and 2025-26. Reports on other regeneration programme activity is not included as this was covered in the report for the Board on 7th March.

1.0 UK Shared Prosperity Fund (UKSPF) 2025-26

EMCCA have confirmed the allocation for Ashfield for 2025-26 of £1,305,176. (Capital £571,831, Revenue £733,346).

We are required to submit our proposed programme to EMCCA by 4th April and they will need to submit an area wide forecast to government by 1st May. EMCCA will receive the funds once the forecast has been submitted and the Memorandum of Understanding has been signed by EMCCA and government. The Council has received a draft grant funding agreement from EMCCA which is currently being reviewed.

EMMCA have confirmed that they will accept activities starting at the start of the financial year if suppliers are willing to start work at risk.

Fund overview

The fund's three priority areas of Communities and Place; Support for Local Business; and People and Skills are unchanged. There is some redefinition of the three priorities to align with the government's five Missions and a reduction from the 53 interventions to 12 as detailed below:

1. Communities and Place

- a) **Healthy, Safe and Inclusive Communities:** Improving health and wellbeing, reducing crime and the fear of crime, bringing communities together and tackling homelessness.
- b) **Thriving Places:** development of the visitor economy, high streets and town centre improvements.

2. Supporting Local Business

- a) advice and support to business, enterprise culture and start-up support, as well as business sites and premises.

3. People and Skills

- a) **Employability:** supporting people, including economically inactive, to progress towards and into sustained employment and support for young people who are at risk of becoming NEET.
- b) **Essential skills** (including numeracy, literacy, ESOL and digital) and employment related skills.

Funding for 2025-26 can be used to support activities from 1 April 2025 to 31 March 2026, including continuations of existing activity where appropriate.

Reporting will continue to be every six months through EMCCA.

[UKSPF additional-information](#) updated and published on 4th March, this document mainly focuses on outputs and outcomes, monitoring and evaluation, branding and publicity and equalities.

Allocations

The Funding Subgroup met on 26th February to discuss UKSPF and the group's remit. Revised Terms of Reference have been agreed which now include a broader remit around funding and monitoring and evaluation. A vice chair – Peter Edwards has been appointed to support the chair, Simon Martin.

The group discussed the process for allocating funds and consultants were appointed to undertake a scoring process based on criteria including alignment to UKSPF interventions, response to identified local challenges, links to Ashfield strategies and action plans, local opportunities, additionality, transformative potential, deliverability and risk assessment / experience of delivery.

Following the initial scoring the funding group met on 12th March and agreed that a further refinement was needed which included adding in the additional criteria of:

- Geographical spread
- Evidence of collaboration
- Any duplication
- Scalability
- Replicability for future

The subgroup met again on 20th March, the further scoring by the consultants was not available for the meeting. The group discussed the approach and the split of the funding across the three themes. There was a discussion about the funding being split equally across the three themes but due to the revenue/ capital split and the concentration of capital schemes within Communities and Place this would mean that there was no revenue within that theme. This area had the highest value of bids and EMCCA will be providing some elements of business support and Enterprising Ashfield is providing business support in Kirkby and Sutton. On this basis it was agreed that there would be a higher allocation in the Communities and Place theme.

The funding requires that in general activity should be part of a tender process. This would mean that some of the larger asks by community organisations would need to go through a procurement process which would reduce the time available to deliver the projects. It was agreed that the community grants scheme proposed by the Council could be expanded to include larger grants of up to £10k. These grants would be assessed by the Be Healthy, Be Happy subgroup (as per current arrangements) and then taken through the Funding Subgroup.

In order to meet the EMCCA submission deadline and to maximise the project delivery timeframes the Funding Subgroup agreed that the Council would put together a proposal for the allocation of funding based on the scoring and feedback from the group and the Council's Executive Director for Place and the Executive Lead Member for Growth, Regeneration and Local Planning and to circulate to the group for review. The Funding Subgroup with the Discover Ashfield Chair would then review and sign off the proposal on the Board's behalf.

Decision 1

The Board is asked to agree that the Funding Subgroup with the Discover Ashfield Chair sign off the funding allocations for UKSPF 2025-26 to be submitted to EMCCA.

2.0 UKSPF Review 2022-2025

A review has been undertaken of the three-year UKSPF programme. As reported earlier in March there are several projects where an underspend has been identified. The underspend is for a variety of reasons, including limited resource within the Council and ongoing recruitment challenges, lower than anticipated demand for grants and lower than expected costs. In order to demonstrate spend of the full UKSPF allocation it is recommended that the underspend is reallocated to other projects. The recommendations are outlined below.

Regarding the underspend in Hucknall that has already been reported, MHCLG confirmed that the funds can be carried over into 2025-26 due to the ongoing uncertainty with the status of the Levelling Up Fund offer which was then withdrawn. The allocated UKSPF funds were being used as co-funding for the LUF programme.

- E1 Hucknall TC - High Street property improvement fund - underspend of £175,619.35 to be carried forward and allocated to the Central Walk scheme.
- E6 St Mary Magdalene – the church was awarded a grant of £25,000 to support the development of the visitor experience project and the bid to National Lottery Heritage Fund (NLHF). The church has made good progress with commissioning reports and design work, but was advised by NLHF to delay submission until the outcome of the LUF consultation process was known. The underspend of £15,139 will be carried forward into next financial year to support the development and submission of funding bids.

Across the rest of the programme, projects where there is identified underspend are as follows:

E5 Coxmoor Env improvements to reduce crime & ASB

E6 Visitor Economy Destination Management Plan, Signage and Stanton Hill Investment Plan.

E9 Green Social prescribing & E10 Cycling and Walking for all – grants

E15 Digital support for local communities

E16 Programme design, etc, of property fronts

E16 Online Trading Opportunities

E23 Specialist events/talks for businesses

E24 High Pavement Business Hub rental incentives

A full report will be provided at a future board meeting on the detail of the underspend which is estimated to be around £88k which is less than 3% of the overall allocation.

It is recommended that the underspend is allocated to other projects which will be either ADMC Next Steps project (funded through UKSPF), Low Street improvements in Sutton (Future High Streets Fund) and/or other suitable projects. Further work is needed to review the outputs and outcomes across the programme to inform the allocations. This will be reported at a future board meeting.

Decision 2 – the Board is asked to consider and agree the proposed reallocation of the underspend from the UKSPF projects as outlined above.

A report and presentation on the outputs and outcomes of the programme will be brought to the board in June.
