- Assessment of health risks and impacts (EQRS, EQIS, EQIS-PA), area studies;
- Proposed measures to combat local pollution (ERC sequence, air treatment, monitoring plans).
- Turnkey air treatment solutions, eco-designed alternatives to traditional methods (laser filtration, biolavage, etc.)
- Availability of the best technologies on the market: COFRAC-accredited olfactometry laboratory, mobile laboratory for on-site analyses, accredited sampling, measurement drones, observatories with real-time alert systems for pollution peaks, 2D/3D modelling.

For Egis group, this new acquisition is fully in line with its "Impact the Future" strategic ambitions, aimed in particular at developing an engineering and operations offer that effectively meets the challenges of climate change, for facilities and infrastructures that produce less carbon.
