WHAT IS THIS PRODUCT

The O ordinary shares of 1p each (Shares) of the Company, which is a venture capital trust ("VCT") and a self-managed Alternative Investment Fund ("AIF"), are listed on the premium segment of the Official List of the UKLA and admitted for trading on the Main Market of the London Stock Exchange. There is no specified maturity date or unilateral termination date.

Objectives:

Type:

To provide high long-term tax-free returns to investors through a combination of dividend yield and capital growth, by investing primarily in smaller in unquoted companies that generate electricity from solar power systems and benefit from long- term government-related price guarantees as well as companies that generate and sell data derived from their ownership and operation of smart data assets. The value of the Shares, and income therefrom, will depend on the performance of the underlying investments. It is also the Company's objective to continue to qualify as a Venture Capital Trust so that shareholders benefit from various available tax reliefs.

What are the main factors likely to affect future returns?

Investment Performance Information

The main factors likely to affect future returns include:

- Valuation The net asset value of the Shares will reflect the values and performance of the underlying investments in the portfolio. There is no certainty that the market price of the Shares will fully reflect the underlying net asset value or that Shareholders will be able to realise their shareholding or that dividends will be paid.
- Underlying Investments Investment in smaller and unquoted companies is likely to involve a higher degree of risk than investment in larger companies and those traded on the main market of the London Stock Exchange. Smaller companies generally may have limited product lines, market, financial or human resources. They may incur unplanned costs and delays as a result of statutory and regulatory requirements.
- Legal Changes to the existing tax laws, regulations and legislations, specially VCT rules, may change during the life of the Company and such changes might affect investor returns.

How does the target compare with performance and volatility?

The Company aims to achieve returns sufficient to cover the stated dividend policy and expenses on an annual basis and to exceed the target for total return of 130p over 6 years. This will depend primarily on profits generated from realisations within the portfolio and the timing of those realisations. Returns will be generated through the growth in NAV and the sale of shares in underlying investments. The main key factors that will affect returns are solar system costs, location regarding solar radiation, and leverage and realisation. What is the most relevant benchmark?

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

No relevant benchmark is available as there is no single benchmark that adequately measures the performance of small, unquoted companies.

What could affect my return positively?

A strong growing economy, a stable political environment, diverse portfolio, robust performance of investee companies, lower operating costs, reduced prices of solar panels and other capital equipment's might positively affect returns.

What could affect my return negatively?

Economic and global political uncertainty, low levels of solar radiation, changes in the rates of Feed-in Tariffs, interest, inflation, high operating costs, failure to obtain accreditation and registration with Ofgem for PV installations might adversely affect returns.

What can be expected if Fund is encashed under severely adverse market conditions?

The secondary market for VCT shares is generally illiquid and Shareholders may find it difficult to realise their investment. Due to the illiquid nature of VCT shares, investors may find it difficult to realise their investments under severely adverse market conditions. WHAT HAPPENS IF FORESIGHT SOLAR & TECHNOLOGY VCT PLC IS UNABLE TO PAY OUT?

The Company is not required to make any payment to you in respect of your investment. As a Shareholder you have no access to the Financial Services Compensation Scheme and would not be able to make a claim to the FSCS about the Company. A default by the Company or any of the underlying holdings could affect the value of your investment. Should the Company be liquidated, the amount you receive for your holding will be based on the value of assets available for distribution after all other liabilities have been paid.

WHAT ARE THE COSTS?

Costs over Time

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs. HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

RECOMMENDED MINIMUM HOLDING PERIOD: 5 YEARS

You should be prepared to hold your shares for a minimum of 5 years as VCTs are intended to have a long investment horizon. If you sell your shares earlier, you will be required to repay any initial income tax relief you claimed. It is recommended that you hold your shares for more than 5 years, as VCTs are intended to have a long investment horizon. An investment in the Company should be considered as a long-term investment.

The Company does not have a fixed winding up date and therefore, unless shareholders voted to wind-up the Company, Shareholders will only able to realise their investment through the market. You may sell your investments within the recommended holding period without penalty fee.

The Company's share prices are quoted on the London Stock Exchange so, provided there is a willing buyer, you may realise your investment through a stockbroker or share dealing account. Previously owned VCT shares do not qualify for initial income tax relief and there is, therefore, a limited market for secondary VCT shares. The price you receive on the open market may therefore not reflect the underlying net asset value of the shares. The Company aims, but is not committed, to offer liquidity to shareholders through an ongoing share buyback policy, subject to cash availability, at a target discount of 0% to net asset value. In line with regulation governing public companies, there are specific periods when buybacks are prohibited, such as when the Company is preparing its annual and half-yearly reports and accounts.

HOW CAN I COMPLAIN?

As a shareholder of the Company you do not have the right to complain to the Financial Ombudsman Service (FOS) about the management of the Company. OTHER RELEVANT INFORMATION?

Tax relief

- (a) Income tax
- (i) Relief from income tax on investment

A qualifying investor subscribing for new Shares will be entitled to claim income tax relief on amounts subscribed up to a maximum of £200,000 invested in VCTs in any tax year. The relief is given at the rate of 30% on the amount subscribed for VCT shares regardless of whether the qualifying investor is a higher rate, additional rate or basic rate tax payer, provided that the relief is limited to the amount which reduces the qualifying investor's income tax liability to nil. Investments to be used as security for or financed by loans may not qualify for relief, depending on the circumstances.

(ii) Dividend relief

A qualifying investor, who acquires shares in VCTs in any tax year costing up to a maximum of £200,000, will not be liable to income tax on dividends paid on those shares and there is no withholding tax thereon.

(iii) Purchases in the market

A qualifying investor who purchases existing shares in the market will be entitled to claim dividend relief (as described in paragraph (a)(ii) above) but not relief from income tax on investment (as described in paragraph (a)(i) above).

(iv) Withdrawal of relief

Relief from income tax on a subscription for VCT shares will be withdrawn if the VCT shares are disposed of (other than between spouses or on death) within five years of issue or if the VCT loses its approval within this period as detailed below. Dividend relief ceases to be available if the VCT loses its approval within this period, as detailed below, or if shares are no longer owned by a qualifying investor.

- (b) Capital gains tax
- (i) Relief from capital gains tax on the disposal of VCT shares. A disposal by a qualifying investor of VCT shares will give rise to neither a chargeable gain nor an allowable loss for the purposes of UK capital gains tax. The relief is limited to the disposal of VCT shares acquired within the limit of £200,000 for any tax year and does not apply where VCT shares were issued after 5 April 2014 and are repurchased by the VCT directly from the shareholder within three years of issue.
- (ii) Purchases in the market

An individual purchaser of existing VCT shares in the market will be entitled to claim relief from capital gains tax on disposal (as described in paragraph b(i) above)
