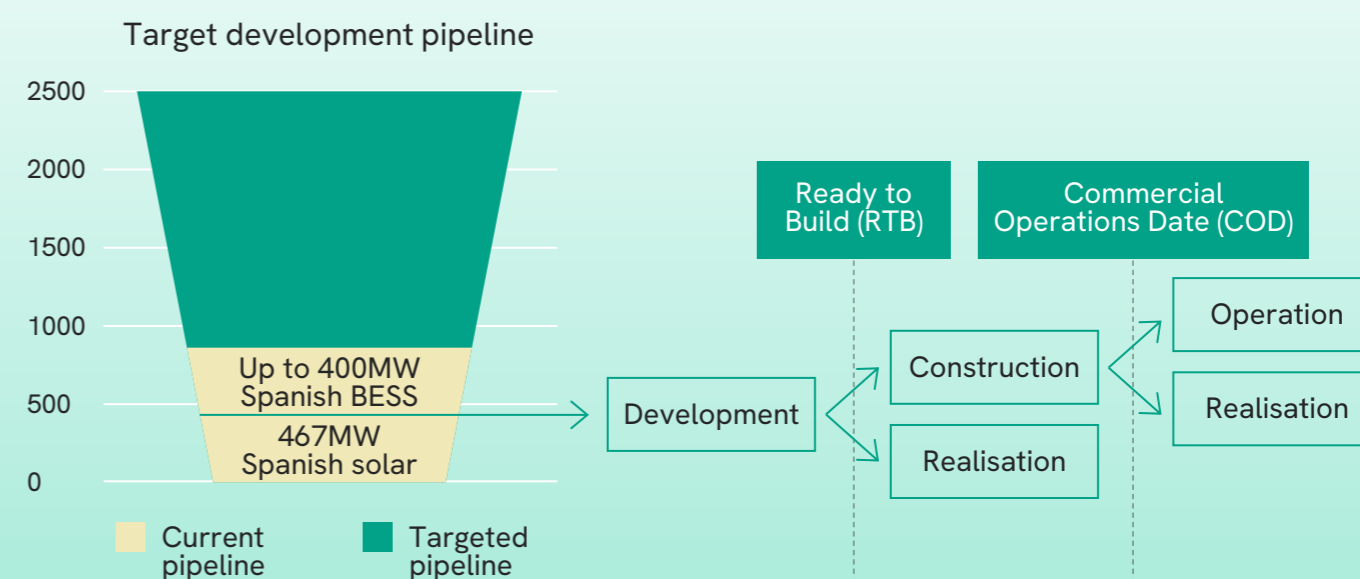
Financial and operational update

- Below-budget irradiation in the UK and curtailment in Spain led to electricity generation under forecast. The first quarter is seasonally weaker for production.
- The removal of the Carbon Price Support (CPS) mechanism will have a limited effect on NAV, estimated between 0.5pps and 1.0pps. No adjustment has been made while the Company awaits independent forecasters' updated power price assumptions. The announced changes to the Electricity Generator Levy do not impact FSFL's NAV.
- The policy moves as stated so far are not expected to affect Foresight Solar's 8.10pps dividend target or its anticipated 1.1x dividend cover for 2026.
- Will Morgan has joined Foresight Group as a Managing Director to lead Foresight Solar's investment management team.

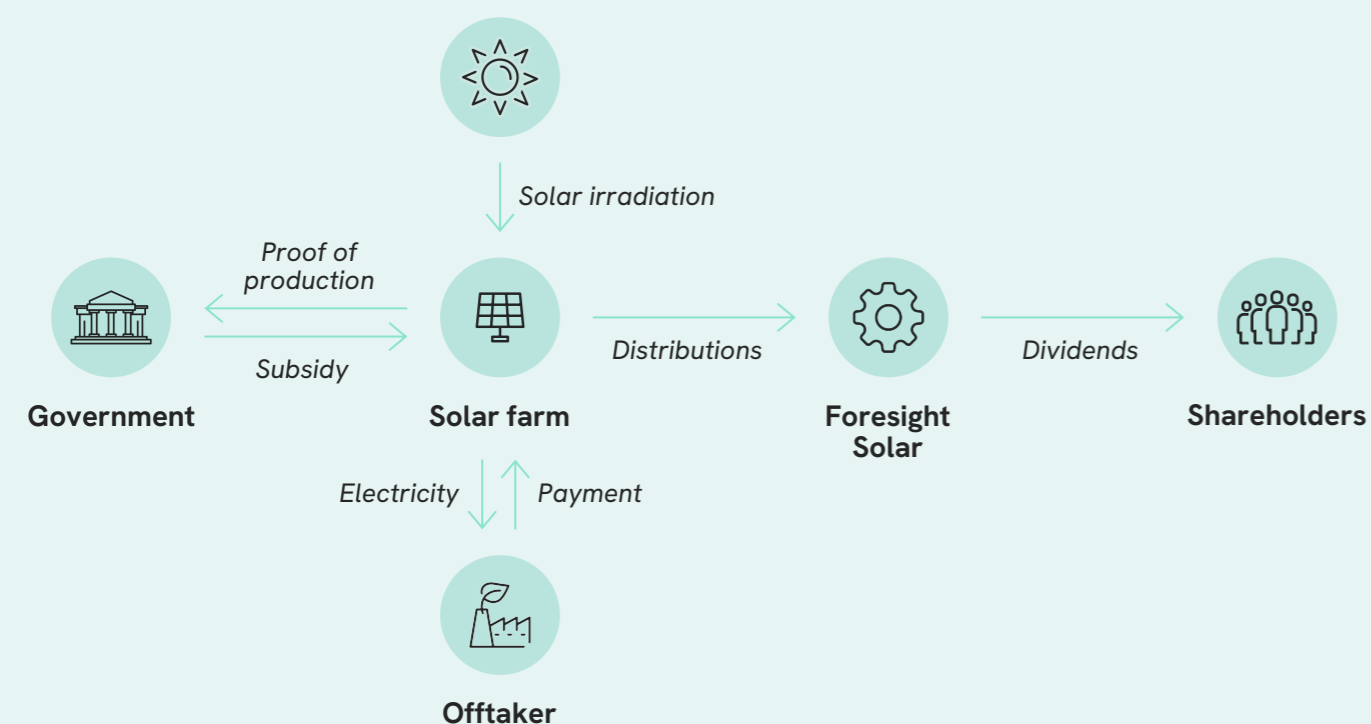
