

Investment Objective Achieving long term capital growth in real terms and steadily increasing income. Our aim is to achieve a higher rate of total return than the FTSE Actuaries All-Share Index Total Return through investing in a diversified portfolio of stocks.

Fund Managers' Comments

In June the Trust's net asset value (cum income, with debt at fair value) fell 2.5%, underperforming the FTSE All-Share benchmark which fell 1.1%. Within this (and in contrast to May), small and medium sized UK companies (for example the FTSE AIM and FTSE 250 indices) underperformed large companies within the FTSE 100. This may have been due to nervousness in equity markets around elections (both in the UK and on the Continent), with smaller companies tending to be, on average, more cyclical in their exposure and therefore more exposed to 'risk-off' market sentiment.

At the portfolio level, the largest detractor was fuel cell developer AFC Energy, which announced an equity raise at a discount in order to investment in its fuel cell development and commercialisation. Elsewhere a challenging ad market backdrop impacted Next 15 Group and this was also one of the weaker performers. Helping to offset this was ongoing takeover activity, with DS Smith (which has agreed to a takeover from US peer International Paper) and Plant Health Care (which has agreed to a takeover from Indian firm PI Industries) both among the top contributors.

During the month we took profits in some names held that have performed well including Rolls-Royce, Natwest and Marks & Spencer. With the proceeds we added to existing holdings such as mixed use property owner Land Securities, building materials producer Ibstock and broadcaster ITV.

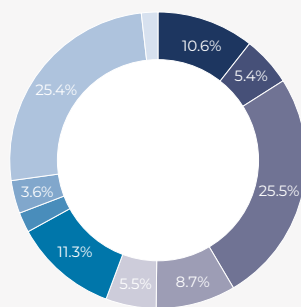

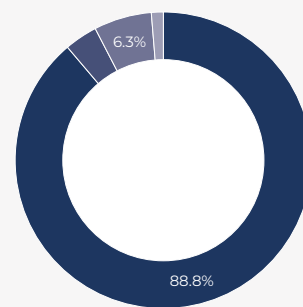
