

Investment Objective Achieving long term capital growth in real terms and steadily increasing income. Our aim is to achieve a higher rate of total return than the FTSE Actuaries All-Share Index Total Return through investing in a diversified portfolio of stocks.

Fund Managers' Comments

In May the Trust's net asset value (cum income, with debt at fair value) rose 5.0%, outperforming the FTSE All-Share benchmark which rose 2.4%. May saw a marked improvement in the performance of UK smaller companies with, for example, the smaller company FTSE AIM All-Share Index and mid-sized FTSE 250 Index outperforming the FTSE 100 Index of larger companies. This benefitted the relative performance of this portfolio, which holds comparatively more than its benchmark in UK smaller companies. This is because in the Fund Manager's view it is often smaller, domestic businesses that currently present the most attractive valuation opportunity.

During the month one of the best performing stocks was retailer Marks & Spencer, which reported better than expected trading in both its clothing and food businesses. Other good performers included textile rental firm Johnson Service Group, which is benefitting from a fall in energy costs and IDS (previously Royal Mail), which received a recommended takeover offer (the position has since been sold). Among the worst performers during the month were some of the industrial holdings including TT Electronics and Dowlais, where some end markets remain challenging.

New positions in May included office owner and developer Great Portland Estates and energy services company Centrica. We also added to existing holdings including BT, Marshalls and Smith &
