### Feedback on the Draft National Infrastructure Plan

I commend the plan's focus on equitable, sustainable, and resilient infrastructure investment. However, I believe the plan would benefit from a dedicated section on Community Impact and Social Value.

### Why a Dedicated Section is Important

While the plan includes elements of community impact, such as equity, workforce development, resilience, and localised solutions, these are dispersed across various sections. A dedicated section would:

- **Centralise Community Impact Goals:** Ensure that social value considerations are not treated as secondary but are central to infrastructure planning and decision-making.
- **Provide Clarity and Focus:** Create a clear framework for addressing community needs, making it easier for stakeholders to understand how infrastructure investments deliver meaningful outcomes.
- **Strengthen Accountability:** Enable better tracking and reporting of social value outcomes, ensuring that investments align with community priorities.
- **Enhance Integration:** Help embed community impact considerations across all infrastructure sectors, from transport to housing to healthcare.

### How This Section Would Support the Plan's Goals

The plan already emphasises equity, resilience, and localised solutions, but a dedicated section would help deliver on these aspects more effectively:

- 1. Equity and Inclusion:** A standalone section could provide strategies for addressing disparities in access to infrastructure, particularly for underserved populations, including Māori and rural communities.
- 2. Localised Solutions:** It could offer guidance on tailoring infrastructure investments to the unique needs of different regions and communities, ensuring alignment with the plan's focus on regional development.



**3. Community Engagement:** While the plan mentions consultation, a dedicated section could emphasise co-designing projects with communities to foster trust and ensure their voices are heard.

**4. Resilience and Sustainability:** It could outline how infrastructure investments can enhance community resilience to natural hazards and climate change, aligning with the plan's emphasis on sustainability.

#### What This Section Could Include

- **Social Value Metrics:** Indicators for measuring outcomes, such as improved health, education, employment opportunities, and environmental benefits.
- **Community Engagement Framework:** Best practices for involving communities in the planning, design, and delivery of infrastructure projects.
- **Localised Strategies:** Guidance on addressing specific regional challenges and opportunities.
- **Accountability Mechanisms:** Transparent reporting on how infrastructure investments deliver social value.

#### Additional Suggestions
