I write in reply to your Official Information Act request, received on 23 May 2024. You requested:

"any advice the Infrastructure Commission has given regarding work on a Waitematā Harbour Crossing (Possibly called Waitematā Harbour Connections).

I am seeking this from October 2023 to present, and am especially interested in any advice given this year."

You subsequently clarified that your request is in relation to advice Te Waihanga has given to the Minister for Infrastructure.

Information being released

Please find attached a series of extracts from the weekly reports that we provide to the Minister for Infrastructure¹, which have information within scope of your request. A list of these extracts is provided at Annex 1. We have not taken the step, in each case, of providing the entire document with redactions – as this would involve a lot of redactions for information that is not in scope.

Parts of the extracts being released to you have been redacted for one or more of the following reasons:

- the information is out of scope
- s9(2)(f)(iv) the information is being actively considered by Ministers and is therefore withheld to maintain the current constitutional conventions protecting the confidentiality of advice tendered by Ministers and officials.

Other than these items, we have not provided briefings to the Minister within the timeframe of your request.

However, as the extracts we have released to you indicate, the Minister of Transport is currently preparing a Cabinet paper on next steps for progressing the Waitematā Harbour Connections business case, and we have been providing input to the Ministry of Transport for development of this draft Cabinet paper. We understand that the Ministry of Transport is considering an approach for the release of this wider advice (briefings and Cabinet papers) and will respond to you on this.

In making my decision, I have considered the public interest considerations in section 9(1) of the Official Information Act.

Please note that this letter (with your personal details removed) and the enclosed documents may be published on Te Waihanga's website.

This reply addresses the information you requested. You have the right to ask the Ombudsman to investigate and review my decision. You can find information about how to do this on the Ombudsman's website.




Waka Kotahi has recommended to the Minister that the next Phase should involve:
