2. Key issues and updates

2.1. National Infrastructure Plan (NIP)

Overview of support research and work to be published

When we publish the draft National Infrastructure Plan on ^{s9(2)(f)(iv)} we intend to publish several technical reports that underpin aspects of the Plan at the same time. These supplementary reports will include a report on the Public Investment Management Assessment (PIMA) in relation to infrastructure, a research report on public agreement and community expectations related to infrastructure, and draft results and background technical papers from our infrastructure needs analysis. More detail about each of these reports is available in Appendix A. We note that the publication timing on these reports may need to be adjusted based on our internal and external review processes.

Further technical reports will be published in the months following the release of the draft Plan. These reports, along with several of our ongoing work, such as the National Infrastructure Pipeline and Infrastructure Priorities Programme, will contribute to the evidence base for the final Plan.

Process and timeframes for release of the Draft and Final National Infrastructure Plans

We have provided a briefing [TW-2025-550] on the timeline and process for delivering the Draft National Infrastructure Plan. The briefing covers the processes for your engagement with your Ministerial colleagues, and providing feedback on the Draft Plan, and development of the final Plan and Government response. We have worked with Treasury on this briefing to include the steps they will lead in the process. During May and June Geoff Cooper, Chief Executive, will continue to meet with opposition infrastructure spokespeople and MPs and Government coalition MPs to brief them on the Plan, to help build cross-party support,
